Student Scholarship Policy



1 PURPOSE

Scholarships are awarded to future students to recognise strong academic performance and innovation as well as enable better access so that students can reach their full potential and build on their education aspiration.

This aspect of financial support is a key feature in Axial International Colleges holistic provision of services to international students and will strengthen our standing as Australia's most accessible and inclusive college across the disciplines we offer.

2 INTERNATIONAL STUDENT SCHOLARSHIP

The International Student Scholarship is available to all new international Dual qualification students who meet the academic criteria at Axial International College. The Scholarship rewards successful applicants with up to the value of 20 per cent of your tuition fees for the duration of your studies, subject to meeting terms and conditions.

Scholarship Value: 20% of your tuition fees **Length of Scholarship**: Duration of course

Number Available: Unlimited

2.1 TERMS AND CONDITIONS

All International Student Scholarship recipients are governed by these terms and conditions.

- The International Student Scholarship is awarded, at the discretion of the College, to exceptional international students, undertaking on-campus, full-time Vocational study at Axial International College
- 2. The International Student Scholarship is only available to students applying for Dual Qualification or Advanced Diploma coursework.
- 3. The International Student Scholarship is only available for full qualification courses (No credit transfers accepted).
- 4. The International Student Scholarship is only available to students new to Axial International College it is not available to students who are currently studying at Axial International College. Students currently studying at Axial and applying for Change of Course will also not be eligible for the International Student Scholarship.
- 5. The International Student Scholarship is not available in conjunction with any other Axial International discount or financial hardship bursary that has been applied to fees.

- 6. The International Student Scholarship is not available to any student who has been given entrance to Axial International College based on work experience.
- 7. The International Student Scholarship is not transferable to a third party or redeemable for cash.
- 8. The International Student Scholarship is calculated and applied on a per term basis.
- 9. The International Student Scholarship remains valid whilst the recipient:
 - a. remains enrolled in full-time study in compulsory terms at Axial International College; and
 - b. remains enrolled in the course listed on their Letter of Offer; and
 - c. pays all tuition and additional fees/costs in accordance with Axial International College policy; ensuring tuition fees are paid in full on time, and
 - d. meets the conditions of their student visa.
- 10. The International Student Scholarship will discontinue if the student named on the Letter of Offer:
 - a. has overdue tuition fees and/or outstanding debts after the start date of each term
 - b. graduates from their nominated course; or cancels their enrolment, or has their enrolment cancelled at Axial International College.
- 11. As per the refund policy, refund amounts payable to international students may be adjusted to include the recouping of waived published fees such as the repayment of any international student scholarships in accordance with the terms and conditions of those scholarships.
- 12. If an international student cancels their studies at Axial International College prior to the completion of their studies as per their Letter of Offer and COE and/or, if an international student transfers to a different Education Provider, the international student must repay the International Student Scholarship fees for each term that was completed. Fees owing may be deducted from any refund that is payable by the College or an invoice for the amount of Scholarship deducted for each relevant term prior to the request for cancellation will be sent to the student for payment.
- 13. The International Student Scholarship may be withdrawn with 10 days' written notice, should the recipient breach any of these terms and conditions.

2.2 APPEALS

There is no right of appeal should the applicant be unsuccessful in securing a scholarship or has their scholarship withdrawn. The terms and conditions may be changed at any time

and the College will provide 20 working days' written notice to all current International Student Scholarship recipients. Students who are uncertain about any of the terms and conditions, are encouraged to speak to the Student Experience Officer at their campus.

2.3 ELIGIBILITY CRITERIA

Applicants who have successfully completed their most recent studies in a secondary education environment or the equivalent to an Australian undergraduate qualification or post graduate qualification in their country with a minimum overall grade average of 75% or higher (or equivalent) may be considered eligible for the International Student Scholarship.

2.4 SUPPORTING DOCUMENTATION

The applicant must provide all certified or original translated completion certificates and academic transcripts to enable an assessment of your application.
